- 2a. The University does not certify the genuineness of the Fire safety Certificate. Last year, around 200 colleges through online verification, were found to have submitted fake FSCs and on the basis of these certificates, they had got recognition from the appropriate authority. However, this year, the same site has discontinued the facility of checking the genuineness of such certificates. So this cannot be certified by us.
- 2b. The University will not guarantee the physical presence of the faculties. The University once tried to verify the presence of the faculties physically. But because of stiff resistance from most of the private colleges, this could not be done. The University has certified the presence of the faculties based on the papers submitted by the colleges, as is done by the NCTE.
- 2c. The University will not guarantee the genuineness of the Bank Statements submitted by the colleges as proof of salary paid to the faculties individually. Many of these Bank statements have been complained to be self-prepared by the colleges and are fake. The University has no scope for verification of the genuineness of these Bank statements, as no bank will allow a third party (Here, University) to have access to the bank details of its customer (Here, College).
